As required by Order No. 5: Setting Procedural Schedule, Complainant Apple Inc. (“Apple”) and Respondent Eastman Kodak Company (“Kodak”) hereby submit their first Joint Report regarding settlement progress.

Counsel for Apple and Kodak met with James Holbein from USITC Docket Services to discuss participation in the Commission’s Pilot Mediation Program for Section 337 Investigations. Apple and Kodak agreed to attempt to arrange a mediation for July or August 2010 and have selected Hon. Eugene F. Lynch (Ret.) of JAMS as the mediator.


